CITIC Envirotech Ltd recorded a net profit of S\$23.6 million for the third quarter ended 30 September 2016

- 9-month net profit after tax increased 114.6% to \$\$59.2 million
- Total revenue increased 93.4% to S\$137.1 million from S\$70.9 million
 - > Engineering revenue tripled to S\$83.0 million
 - Membrane sales increased 34.9% from S\$10.6 million to S\$14.3 million
 - ➤ Recurring water treatment revenue up by 22.1% from S\$32.6 million to S\$39.8 million

Singapore, **26 October 2016** – Mainboard-listed CITIC Envirotech Ltd ("CEL" or "Group"), a leading membrane-based water treatment solutions provider reported a 57.4% increase in net profit after tax for the third quarter FY2016 to S\$23.6 million as compared to the last corresponding period ended 30 September 2015. The total net profit after tax for the 9-month period from January to September 2016 amounts to S\$59.2 million on the back of a total revenue of S\$376.5 million.

For the third quarter FY2016, the Group recorded a revenue of \$\$137.1 million, which was \$\$66.2 million or 93.4% higher than the last corresponding period ended 30 September 2015. This was due to the increase in revenue of all three business segments, namely, engineering, membrane sales and water treatment.

Engineering revenue increased from S\$27.7 million to S\$83.0 million, representing an increase of S\$55.3 million or 199.6%; and membrane sales increased from S\$10.6 million to S\$14.3 million, representing an increase of S\$3.7 million or 34.9%. The Company continues its growth momentum in the recurring water treatment business segment and its recurring water treatment revenue increased S\$7.2 million or 22.1% to S\$39.8 million for the guarter ended 30 September 2016.

During the period, the Company issued USD180 million perpetual capital securities with effective coupon of 4.25%. Partial of the proceeds were used to repay the first S\$100 million 7.25% Medium Term Notes ("MTN"). The Company continues to explore various channels of financing to lower its overall cost of borrowings in order to stay competitive in this capital-intensive water industry.

CITIC Limited is China's largest conglomerate operating domestically and overseas, with businesses in financial services, resources and energy, manufacturing, engineering, contracting and real estate, as well as other services.
