(i) the KKRCW Swap, which, on the KKRCW First Completion Date, have resulted in KKRCW subscribing for 151,097,815 Offeror Shares as settlement of the consideration payable by the Offeror to KKRCW for KKRCW's tendering of all its 285,609,818 UEL Shares in acceptance of Offer, thus causing KKRCW to have deemed interests in the UEL Shares held indirectly by the Offeror through KKRCW's more than 20% shareholding interest in the Offeror immediately after the KKRCW First Completion Date; and

(ii) the KKRCW Swap, which, on the KKRCW Second Completion Date, have resulted in KKRCW subscribing for 117,926,189 Offeror Shares as settlement of the consideration payable by the Offeror to KKRCW for KKRCW's tendering of all its Convertible Bonds in acceptance of CB Offer, thus causing KKRCW to have deemed interests in the increased number of UEL Shares held indirectly by the Offeror after the close of the Offer through KKRCW's more than 20% shareholding interest in the Offeror after the KKRCW Second Completion Date.
