- a. In paragraph 8 of the Company's FY2015 Results Announcement (the "Announcement"), the Company announced that its non-current assets increased from \$943.4 million as at 31 March 2015 to \$1,200.1 million mainly due to the additions of service concession receivables during the financial year.
 - i. Please provide details of the service concession receivables including the name of such service concession receivables.
